The Compounding Corner

Salt Forms of Drugs in Creams

Recently, I have seen a number of compounded formulations for topical use having a salt of a weak acid (e.g. Diclofenac Na) or a salt of a weak base (Cyclobenzaprine HCI) in a cream. As we all know, salts carry a charge on the molecule and these charged molecules cannot pass through skin tissue by passive, non-ionic diffusion. I would advise one to avoid compounding salt forms of drugs into a formulation that is intended for topical use where one expects the drug to be absorbed through the skin and be therapeutically efficacious. Most muscle relaxants and NSAIDs which are salt forms of drugs are intended for oral use and have proven efficacy only for oral use. Also, a weak acid salt and a weak base salt should never be compounded together for one then obtains an ion pair that will likely develop even in a cream. What should one do when they get a request for such a formulation? First, I would suggest you "Google" the drug or do a similar literature search to see if there is any data that supports topical use. Finding none, I would call the physician who wrote the prescription and ask him for information that supports such usage. Having none, you should be able to ask the physician to change or cancel the prescription. If there is data, have him FAX you a copy and check to be sure the data was published in a reputable, peer reviewed publication [e.g. not in the Journal of Irreproducible Results]. From the article, one should be able to tell where the study obtained the drug and whether the drug was a free acid, a free base or the neutral, uncharged form of the drug.
